WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on

- AND WHEREAS, the recognition was granted by NRC to Shri Rum Institute of Education, Vill.- Sarakikal Madho, Post- Malampur Suroj, Telis" Dhampur, Distt.- Dijnor-246761, Uttar Pradesh for B.Ed. Course vide order no. NRCNCTE/F-73/UP-2048/2008/ 4645. 46456 dated 25.04.2008 with an annual Intake of 100 seats.
- AND WHEREAS, the said institution has by affidavit consented to come under New Regulations and sought for (we basic units in B.Ud., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
 - The institution shall create additional facilities that in nude (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The application-Institution for additional unit will be required to submit the required documents such as (ii) land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforms available on the Website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of
 - The Regional Comm less shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to on oply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the (iv) NCTE Act Complaint etc., the institution shall be required to submit a copy of the Hon'ble Coun order/reply to SCN/complaint/strendy submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint
- New therefore, in the light of the above, the Northern Region: Committee, NCTE hereby issues the revised Recognition Order to Shel Ram Institute of Education, Vill.- Sarakthal Madno, Post- Mojampur Suraj, Tehsil-Dimmpur, Distt.- Bijnor-246761, Uttar Pradesh for conducting B.Ed. programme of two years duration with an admini intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, all liating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulation..., 2014 by the concerned institution before grant of affitiation to an institution.
- ... The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic-year along with the statement of annual accounts duly audited by a Chartered Accountant.
